



## OUT-OF-STATE FEE WAIVER FOR SELECT FLORIDA HIGH SCHOOL GRADUATES

### INFORMATION AND ELIGIBILITY CRITERIA

Effective July 1, 2014, applicable for fall 2014 and thereafter, House Bill 851 amended s. 1009.26, Florida Statutes, *Fee Waivers*, to authorize an out-of-state fee waiver for select students who attended a high school in Florida.

#### Applicants for this waiver must meet the following eligibility criteria:

- Attended a Florida high school for three consecutive years immediately prior to graduation from a Florida high school
- Submitted an official high school transcript providing evidence of high school attendance and graduation
- Submitted an admission application to a Florida College System or State University System institution within 24 months of high school graduation

#### Important Notes:

1. Receipt of this out-of-state fee waiver does NOT constitute classification as a Florida resident for tuition purposes. Students who receive this waiver remain classified as out-of-state (non-Florida) residents for tuition purposes.

2. A student who is granted this waiver is NOT eligible for state financial aid, including Bright Futures.
